A. Case #11-08 Appellant: Jeff Klatt

Property: 26585 Woodlore Parcel ID: 24-06-328-009

Zoning: RM

Description of Proposed Request:

To allow for an Addition and Remodel of an existing residence, subject to the following:

1. Franklin Village Ordinance Appendix B SCHEDULE OF REGULATIONS requires the minimum front yard setback in an RM district of 50 feet. The proposed plan shows an encroachment of the existing non-conforming house of 6.10 feet; therefore the house is located 43.9 feet from the front lot line. A proposed addition planned for the second floor to be located above the first floor in the same area; therefore making the second story addition in violation of the front yard setback ordinance by 6.10 feet. The appellant is requesting a variance from the Zoning Board of Appeals of 6.10 feet of the front yard setback ordinance, to allow the construction of the second story addition as proposed.

B. Case #11-09

Appellant: Village of Franklin

Property: Village Green, behind the Franklin Public Library Parcel ID: 24-06-253-184 to 195 and 24-06-253-157 to 168

Zoning: R-1

Description of Proposed Request:

To allow for Temporary off premise signs for the Village Green Ice Rink, sponsored by the Farmhouse Coffee and Ice Cream, subject to the following:

- 1. Franklin Village Ordinances 1474.11 (O) Prohibited Signs, states in part that "The following signs are prohibited: ...(O) Off-Premise advertising sign and billboards..." The appellant is requesting that signs be placed at the Village Ice Skating Rink that is being sponsored by the Farmhouse Coffee and Ice Cream and that the business name will be listed on the sign, requiring them to be appealed and approved by the Sign Board of Appeals.
